I. Basis of the contract

The following general terms and conditions regulate the relationship between the commissioned company ("contractor") and its customer ("client") as far as the Client is an entrepreneur within the meaning of § 14 BGB.

They apply to all offers and deliveries and services of the contractor vis-à-vis the client, subject to individual differences or agreements between the contracting parties exclusively.

The form reference to general terms and conditions of the client is contradicted.

II. Conclusion of contract

The contract is concluded with the written order confirmation of the contractor.

III. Renting agency

The tenant has to handle the goods carefully. This will be changed in perfect condition.

The rental property is only made available for the purpose and duration of the sale.

There may be deviations in dimensions, shapes and colors. The return is called as soon as possible after the end of the event.

The goods are not insured. It is recommended to take out insurance for the duration of the event, including the setup and dismantling times.

The tenant is liable for damage and losses. Liability begins with delivery and ends with collection, at the latest 48 hours after the end of the event.

This also applies if the stand is not occupied. In the case of lost or damaged rental goods, the lessee must bear the costs for the replacement or repair in addition to the agreed rental price.

The tenant must ensure that the rental property is managed in an appropriate and complete condition. Complaints can only be made within 24 hours of monitoring.

In the event of a justified complaint, the lessor is obliged to deliver an equivalent replacement. The lessor reserves the right to deliver equivalent or better replacement items to the lessee at the same price instead of the rented items. The tenant must return the rented goods in clean condition after use, all fastening materials must be removed without leaving any residue.

The tenant must inform the landlord immediately if the rental object:

- assert third party rights in any form
- not delivered in full, according to the order, on site
- has been damaged
- has been stolen

Withdrawal from a rental furniture order up to € 250.00 is free of charge up to 3 days, with a total value of € 250.00 up to 7 days before the start of the event. In the event of cancellation 48 hours before the start of the event, the full rental price must be paid. The tenant is to withdraw from the contract if the loss cannot be replaced or improved in the same way if the complaint is checked.

IV. Prices

All prices are in EURO without statutory taxes and levies and public law additional levies.

Services not included in the offer, which are carried out at the request of the client or additional expenses that are due to incorrect information provided by the client.

Advance payments by the client or other third parties that have not been made on time or professionally, insofar as these are not vicarious agents of the contractor will be additionally charged to the client posed.

Obtaining required regulatory approvals, concessions, or other Permits are only part of the offer if this is expressly stated. The same applies to the customs formalities for deliveries abroad.

If services are provided at trade fairs, the offer prices do not include the effort and the cost of deliveries and services, exclusively from trade fair companies or must be used by these commissioned third parties, such as freight forwarding services on the exhibition site (e.g. transport on the exhibition site, provision of forklifts and pallet trucks, empties handling, disposal, etc.), unless these services are on offer expressly named.

The right to terminate for good cause remains unaffected. The prerequisite is that before a corresponding written request to remove the important reason in an appropriate manner The deadline has passed and the deadline has passed without results. One important reason lies in particular then, if the client violates his contractual obligations sustainably or grossly and, in particular, does not properly meet his payment obligations despite being requested to do so complies.

V. Terms of payment

Payment is due at 50% of the order value when placing the order and billing, but at the latest 4 weeks before the start of the event. The remaining amount of 100% as well as and supplements are due when the trade fair begins

and the stand is taken over by the customer, as well as invoicing by M3.

Deviating from our terms and conditions, 100% of the order value is due when placing the order and invoicing in the case of rental assignments.

VI. Delivery / transportation

If the contractor or its sub-suppliers or subcontractors are not responsible Disruptions in business operations, in particular cases of force majeure, strikes and lockouts, which are based on an unforeseeable and faultless event and which lead to serious malfunctions lead, the delivery / completion period is extended accordingly.

If it becomes impossible to fulfill the contract, the parties can withdraw from the contract.

In this case, the contractor is entitled to compensation up to that point services rendered, whereby the services also include claims by third parties that the contractor has entrusted the contract with confidence.

The products and (delivery) items of the contractor always travel at the expense and risk of the client, unless otherwise agreed. Unless specifically instructed, the contractor determines the dispatch at his discretion without responsibility for the cheapest and fastest way.

The desired packaging will be charged separately.

For transports arranged by the customer the goods are only insured at the express instruction and expense of the customer.

Any danger Unless otherwise agreed, passes to the client when the goods become operational of the contractor will otherwise leave if they are made available to the client.

Any risk passes to the customer when the goods leave the contractor.

This also applies in cases where freight-free delivery has been agreed.

Objects of the client that are to be used in the provision of services must be delivered to the place of use by the agreed date.

The contractor is not obliged to return these items.

If the return delivery is ordered, it happens unfree from the place of use at the risk of the customer.

If shipping goods or exhibits of the customer are to be transported, the above applies

Regulations accordingly.

VII. Acceptance / handover

An acceptance or handover takes place regularly formally and immediately after completion.

The client undertakes to attend the acceptance date himself or from one to have appropriately authorized representatives represented.

It is expressly recognized that in special cases even an acceptance date one hour before the start of the fair is not inappropriate.

Outstanding partial services or notified defects will be made up for as soon as possible. If they do not significantly impair the function of the subject matter of the contract, they do not entitle them to refuse acceptance.

The prerequisite is that before a corresponding written request to remove the important reason in an appropriate manner. The deadline has passed and the deadline has passed without results he right to terminate for good cause remains unaffected.

VIII. Liability for defects

Liability for defects is based on the statutory provisions, unless otherwise agreed in the general terms and conditions.

If there is a defect that the contractor is responsible for, the customer can only request supplementary performance in the form of rectification.

The type of correction lies with the contractor. The contractor can carry out a replacement delivery. The deadline for claims for defects by the client against the contractor ends at the end of the event. The above restrictions do not apply to claims for damages or reimbursement of expenses based on gross negligence, intent or injury of contractual obligations, the proper fulfillment of which is the implementation of the contract enable in the first place and on the fulfillment of which the customer can regularly rely (hereinafter: "Cardinal obligations").

They also do not apply insofar as claims for damages or reimbursement of expenses due to injury to life, limb or health or claims are affected on the basis of the Product Liability Act.

As far as a cardinal obligation is negligent, the contractor's liability is the amount after limited to such damages and expenses that are typical with the contract connected and predictable.

Unless expressly stated in writing, product descriptions, samples or presentations are not guarantees or property warranties.

IX. Liability

The client is liable to the contractor for all items lent to him on a rental or rental basis. In the event of destruction and loss, the customer bears the costs of restoring or purchasing new equipment.

X. Insurance

For goods stored by the customer, we take action against fire and water damage at the customer's expense and burglary insured.

XI. Retention of title

All delivery items and performance results to be transferred remain completely until
Fulfillment of all liabilities from the contractual relationship between the property of the parties of the contractor.

Any transfer of rights of use and exploitation only becomes effective upon full fulfillment of all liabilities from the contractual relationship between the parties.

Without the consent of the contractor, the customer is not entitled to resell, edit or process.

The client assigns claims for resale in the amount of the delivery including sales tax.

The contractor accepts this assignment.

XII. Exploitation and usage rights, conception

Offers, plans, drafts, drawings, manufacturing and assembly documents, concept descriptions, descriptions of exhibition and event concepts; Print templates and film material of the client remain the property of the contractor with all rights, even if they have been handed over to the client.

To this extent, they are entrusted to the client within the meaning of Section 18 UWG.

The client undertakes to refrain from any other use in all forms, in particular the duplication and distribution, the making of changes, the transfer to third parties or the direct or indirect replication.

A transfer of usage rights to fulfillment of the contract are independent of whether industrial property rights or

Copyrights do not exist or require the express written agreement.

Unless otherwise agreed in writing, changes to plans, designs and concepts are not permitted and can only be carried out by the contractor. This also applies to these documents have become the property of the customer.

It is assumed that the client violates the obligations under this section has when he organizes exhibitions or events, essentially with the planning and concepts of the contractor. The client then reserves the right to provide the opposite evidence.

If the aforementioned obligations are violated, the contractor is entitled to 50% compensation from the agreed rental price.

If the customer provides materials or documents to provide the services, he guarantees that the manufacture and delivery of the the services provided according to his records do not infringe the property rights or copyrights of third parties.

The customer makes all claims for violations against the contractor Property rights or copyrights free.

The contractor is entitled to record the event and the recordings in addition Background information about the project for the purpose of documentation and self-PR to use.

At the request of the contractor, the client is obliged to name the contractor for all publications.

XIII. Termination / cancellation

The client is entitled to terminate the contract at any time.

If the client withdraws from the contract after the order has been placed or up to 1 week before the set-up date, he will be charged for the preparation costs incurred up to that point, as well as the services rendered by third parties.

The right to terminate for good cause or force majeure remains unaffected. The prerequisite is that a corresponding written request to remedy the important reason is given within a reasonable period of time and the period has passed without results. One important reason lies in particular then, if the client violates his contractual obligations sustainably or grossly and, in particular, does not properly meet his payment obligations despite being requested to do so complies.

XIV. Place of performance and jurisdiction

The place of performance and jurisdiction for all disputes arising from the contractual relationship is Magdeburg.

The legal form of the Federal Republic of Germany is decisive, also for business with foreign customers.
